- Examinations should be conducted as suggested by the previous Expert Committee.
- More equipment should be purchased, particularly for weaving Section and Textile Testing Laboratory. Computer facilities should be provided.
- The AICTE scales of pay should be given to the faculty.
- The faculty should be provided as per AICTE mores with prescribed qualifications.
- Admission for 1995-96 will be decided after evaluation by AICTE.
